INCENTIVES

Gratiot County is committed to the success of your project. Greater Gratiot Development, Inc. (GGDI) works as a one-stop shop for new and existing businesses by providing comprehensive development assistance. GGDI works with all municipalities, Gratiot County, and the State of Michigan to provide a comprehensive incentive package for your project. In addition to the **state incentives (click here), GGDI is prepared to assist with:**

P.A. 198 TAX ABATEMENTS (INDUSTRIAL FACILITIES EXEMPTION)

Industrial property tax abatements provide incentives for eligible businesses to make new investments in Michigan. These abatements encourage Michigan manufacturers to build new plants, expand existing plants, renovate aging plants, or add new machinery and equipment. High technology operations are also eligible for the abatement. The abatement amounts to a reduction in property taxes of approximately 50%. **Click here for more information.**

BROWNFIELD TAX INCREMENT FINANCING

The Tax Increment Financing Authority allows municipalities to develop districts with authority to capture taxes due to the increase in property values within a specific district that have resulted from project investments. The districts may be under the jurisdiction of a Downtown Development Authority (DDA), Local Development Finance Authority (LDFA), Tax Increment Finance Authority (TIFA) or Brownfield Redevelopment Authority (BRA). Under the act, the authority may use the captured taxes to pay for water and sewer, roads, environmental testing, and other public investments within the development district, depending on type of authority. FOREIGN TRADE ZONE #275

An FTZ is a federally designated area in or near a U.S. Customs port of entry where foreign and domestic merchandise is categorized as outside the country or outside U.S. Customs territory. Eligible companies within the FTZ No. 275 region can leverage special privileges while performing activities required for manufacturing or distribution. Importers and exporters benefit through streamlined global logistics and reduced overall costs through eliminated, deferred or reduced duties and customs-related fees. **Click here for more information.**

OBSOLETE PROPERTY REHABILITATION ACT-OPRA

The OPRA (P.A. 146) incentive essentially allows property owners that are proposing a building renovation to "freeze" a portion of their real property taxes on the current property's value for a period of up to 12 years. Only commercial property or commercial housing property is eligible and the project must be located in a qualified local governmental unit (Alma, Ithaca, and St. Louis are eligible). The process to secure this incentive includes two public hearings and two council resolutions. In order for a project to be eligible, this incentive must be secured prior to building renovation. **Click here for more information.**

PRIVATE ACTIVITY BOND PROGRAM (FORMERLY INDUSTRIAL REVENUE BONDS)

The Private Activity Bond program is tax exempt financing for fixed asset purchases. The County of Gratiot Economic Development Corporation (EDC) authorizes issuance of the bonds that are sold to single or multiple investors. The Michigan Economic Development Corporation (MEDC) also has a statewide program to issue bonds through the Michigan Strategic Fund. GGDI staff can assist in pursuing these tax-exempt bonds from either source. Click here for more information.

PERSONAL PROPERTY TAX RELIEF IN DISTRESSED COMMUNITIES (P.A. 328)

Personal Property Tax Relief in Distressed Communities allows distressed communities, county seats and certain border county communities to abate personal property taxes on new investments made by eligible businesses. Eligible projects include manufacturing, mining, research and development, wholesale trade and office operations. Retail businesses and casinos are not eligible. **Click here for more information.**

SMALL BUSINESS ADMINISTRATION LOAN PROGRAMS

The U.S. Small Business Administration's (SBA) program provides small- and medium-sized businesses with long-term fixed rate financing for the acquisition or construction of fixed assets. Businesses must have a tangible net worth of less than \$7.5 million and an average net profit of less than \$2.5 million for the past two years. Visit www.sba.gov

AGRIBUSINESS FINANCING PROGRAMS

The Michigan Department of Agriculture & Rural Development (MDARD), in partnership with the Michigan Economic Development Corporation (MEDC), offers multiple programs to help support the financing and growth of agricultural businesses in the state of Michigan. Michigan is an international leader in the agriculture industry, and MDARD and MEDC are committed to supporting the continued growth of the industry within the state. Businesses need capital to grow.
