- Assisted MyMichigan Health in their new surgical suite project at the Alma Hospital, which will greatly increase healthcare access in the region.
- Helped develop the successful Gratiot Young Professionals Network and the GYPN Leadership Development Workshop to assist with talent recruitment and retention in the County.
- Collaborated with regional counties in developing an in-depth two-year Business Attraction Plan for Region 5 (Arenac, Bay, Clare, Gladwin, Gratiot, Isabella, Midland, and Saginaw counties).
- Achieved a clean financial statement audit with no significant findings for FY 2021.
- Earned voter approval of the four-year millage for Economic Development Services in Gratiot County to support GGDI projects.

2023 FOCUS AREAS

Solar Development

Thanks to its early foray into renewable energy with wind development,
Gratiot County has much of the infrastructure and substation capacity necessary to make solar development economically viable.

Solar energy is being pursued in several different capacities. First, large-scale solar, often developed by utility providers, is being pursued in agricultural areas where larger sites can be leased; energy produced goes to the grid for the use of utility customers. Second, solar is being considered on sites with environmental issues to make use of land that otherwise would be too costly to develop. Finally, solar is being incorporated on privately-owned business and residential properties to off-set energy costs.

Talent Recruitment

Talent shortages are now a nationwide problem, regardless of industry. Less people are in the workforce due to demographic changes. This is the number one issue for most businesses.

through several initiatives to increase talent availability in the area. First, the Gratiot Young Professionals Network offers individuals aged 21-40 who live or work in Gratiot the opportunity to network and grow roots in the area. Second, Gratiot County is working with regional partners on a workforce training grant that will assist companies in training new employees. Finally, GGDI continues to work collaboratively with industry and education representatives to ensure students receive appropriate training.

Master Planning

Every five years, municipalities are required by state law to review/update a master plan, which provides the goals, objectives, and strategies that will guide communities over the next twenty years.

Gratiot County is unlike any other in the state, in that all cities, villages, and townships come together to develop a unified Countywide Master Plan.

In 2023, Gratiot will be completing a new Master Plan that will incorporate new Census data, future development goals, and opportunities for collaboration. The Countywide Master Plan relies on public participation and there will be numerous ways to incorporate your ideas, including public participation sessions and online surveys. Completing the Countywide Master Plan will ensure the area is eligible for future grant opportunities from the Michigan Economic Development Corporation (MEDC).
